

**Executive Council Resolution No. (6) of 2025**  
**On Approving Fees and Violations Schedules of**  
**Law No. (8) of 2019**  
**On Regulating Practice of Contracting Profession**

After perusal of Federal Decree-Law No. (42) of 2022  
on Promulgating Civil Procedures Law, as amended;

And Ras Al Khaimah Municipality Law of 1981, as  
amended;

And Law No. (7) of 2012 on Establishing Executive  
Council of Ras Al Khaimah Emirate;

And Law No. (8) of 2019 on Regulating the Practice of  
Contracting Profession, as amended;

And after approval of the Executive Council;

have promulgated the following Resolution:

**Article (1)**

The two schedules of fees and violations attached to  
this Resolution shall be approved.

بعد الاطلاع على المرسوم بقانون اتحادي رقم (42) لسنة 2022  
بإصدار قانون الإجراءات المدنية وتعديلاته،

وعلى قانون بلدية رأس الخيمة لسنة 1981 وتعديلاته،

وعلى القانون رقم (7) لسنة 2012 بشأن إنشاء المجلس التنفيذي  
لإمارة رأس الخيمة،

وعلى القانون رقم (8) لسنة 2019 بشأن تنظيم مزاولة مهنة  
المقاولات، وتعديله،

وبعد موافقة المجلس التنفيذي.

فقد أصدرنا القرار الآتي:

**المادة (1)**

يُعتمد جدولاً الرسوم والمخالفات المرفقين بهذا القرار.

**المادة (2)**

Without prejudice to any more severe penalty stipulated by another law and measures stipulated by Law no. (8) of 2019 referred thereto, everyone commits any of the violations stated in the schedule attached thereto shall be punished by the fine determined for it and the fine shall be doubled in case of repeating the same violation within one year from the date of committing the previous one.

### Article (3)

Any interested party may file a grievance with the Municipality Department regarding the fines and measures imposed thereon in application of this Resolution provisions, within fifteen days from the date of notifying him of the fine or measure and Grievance Committee in the Department shall decide on the grievance within thirty days from the date of submitting it and the decision issued in the grievance shall be final.

### Article (4)

The following conditions must be met to reconcile any of the violations stated in the schedule of violations attached hereto:

1. The violation must not be one of the violations that breaches Code of Ethics for practicing the profession or the requirements of security and safety.
2. Remove violation causes within the period determined by the Committee.
3. Pay the value of damages caused by the violation to public property.
4. Pay half of fine value.

### Article (5)

مع عدم الإخلال بأي عقوبة أشد ينص عليها قانون آخر والتدابير المنصوص عليها في القانون رقم (8) لسنة 2019 المشار إليه، يُعاقَب كل من يرتكب مخالفة من المخالفات الواردة في الجدول المرفق بهذا القرار بالغرامة المُحددة لها، وتتضاعف الغرامة في حال تكرار المخالفة ذاتها خلال سنةٍ من تاريخ ارتكاب المخالفة السابقة عليها.

### المادة (3)

يجوز لكل ذي مصلحة التظلم إلى دائرة البلدية من الغرامات والتدابير الموقعة عليه، تطبيقًا لأحكام هذا القرار، وذلك خلال خمسة عشر يومًا من تاريخ إخطاره بالغرامة، أو التدبير، وتتولى لجنة التظلمات بالدائرة البتّ في التظلم خلال ثلاثين يومًا من تاريخ تقديمه، ويكون القرار الصادر في التظلم نهائيًا.

### المادة (4)

يجب للتصالح عن أيّ من المُخالفات الواردة بجدول المُخالفات المرفق بهذا القرار توفر الشروط الآتية:

1. ألا تكون المخالفة من المخالفات التي تخل بميثاق أخلاقيات مزاوله المهنة أو اشتراطات الأمن والسلامة.
2. إزالة أسباب المخالفة خلال المدة التي تحددها اللجنة.
3. سداد قيمة الأضرار التي سببتها المخالفة للممتلكات العامة.
4. سداد نصف قيمة الغرامة.

### المادة (5)

Fees and fines collected under this Resolution shall devolve upon treasury of the Department and the unpaid thereof shall be collected through a claim issued by the Department Director General or his delegate that includes the name of the debtor and his legal representative and the due amounts and this claim shall be considered writ of execution to be executed by the competent Execution Judge in accordance with Civil Procedures Law.

#### Article (6)

Each provision in other Resolution contradicts with provisions of this Resolution shall be repealed.

#### Article (7)

This Resolution shall come into force as date of its promulgation and be published in the Official Gazette.

## Violations & Fines Schedule

### First: Contracting Establishments Violations & Fines

S. No.	Violation	Fine in AED
1.	An establishment practices the contracting profession with no registration or after deletion or suspension thereof.	50000
2.	An establishment practices the contracting profession after cancellation of its entry in the register due to failure to renew the registration on the specified date.	5000
3.	The establishment commits a serious professional error from among those listed in a schedule issued by resolution from the Director General specifying the errors and the fines specified for them, that shall be not less than the minimum and not more than the maximum stipulated in this clause.	Minimum 5000 Maximum 50000
4.	The establishment practices the profession while its registration is suspended.	20000
5.	Present false documents or papers or provide incorrect information to obtain registration or classification.	Minimum 5000 Maximum 10000
6.	The establishment did not renew registration thereof.	100 And 10 for each delay day
7.	The establishment carries out unlicensed works or works that do not comply with the building permit.	5000
8.	Issued or broadcasted bulletins in the media or other means of advertising with the intention of misleading others into believing that he has the right to practice contracting works despite not being registered or his registration cancelled or being suspended from practicing the profession.	Minimum 5000 Maximum 20000
9.	The establishment waives its license without obtaining Municipality Department approval.	10000

10.	The establishment enters into any contract or agreement with the intention of obtaining benefits or granting others those benefits without providing any serious contracting works.	10000
11.	Failure of the establishment, without an acceptable excuse, to immediately notify the competent authorities of any damages to public property as a result of conducting contracting works thereby.	Minimum 2000 Maximum 10000
12.	The establishment practices works that require a higher classification than the classification approved for it.	5000
13.	The establishment subcontracts with an unregistered contractor.	5000
14.	The establishment does not submit a technical report on the project status upon the request of the competent administration to take procedures to change the contractor.	5000
15.	Failure to notify the relevant division within three working days without an acceptable excuse that one of the engineers registered with the establishment is not working with it anymore.	5000
16.	Failure to notify the relevant department of any change in the facility's conditions or address within sixty days of its occurrence date	5000
17.	The facility recruits an engineer who is not registered.	5000
18.	Any other violations of provisions of mentioned Law no. (8) of 2019 and resolutions promulgated in implementation thereof.	Minimum 1000 Maximum 10000

## Second: Technical Cadre Violations & Fines

S. No.	Violation	Fine in AED
1.	Practice profession in the Emirate without being registered.	20000
2.	Practice profession in a contracting establishment other than the one with which he/she is registered.	20000
3.	The engineer's gross negligence in performing the works assigned thereto, or his failure to take the necessary precautions, which caused damages to the safety of persons, property, or environment.	Minimum 5000 Maximum 20000
4.	The engineer registers in the registry within the technical cadre of an establishment or moves from one establishment to another with the aim of making the establishment obtains the classification without actually and seriously practicing his professional duties.	10000
5.	A technical cadre is registered in the registry within the cadre of more than one contracting establishment at the same time.	10000
6.	Any other violations of provisions of mentioned Law no. (8) of 2019 and resolutions promulgated in implementation thereof.	Minimum 1000 Maximum 3000
